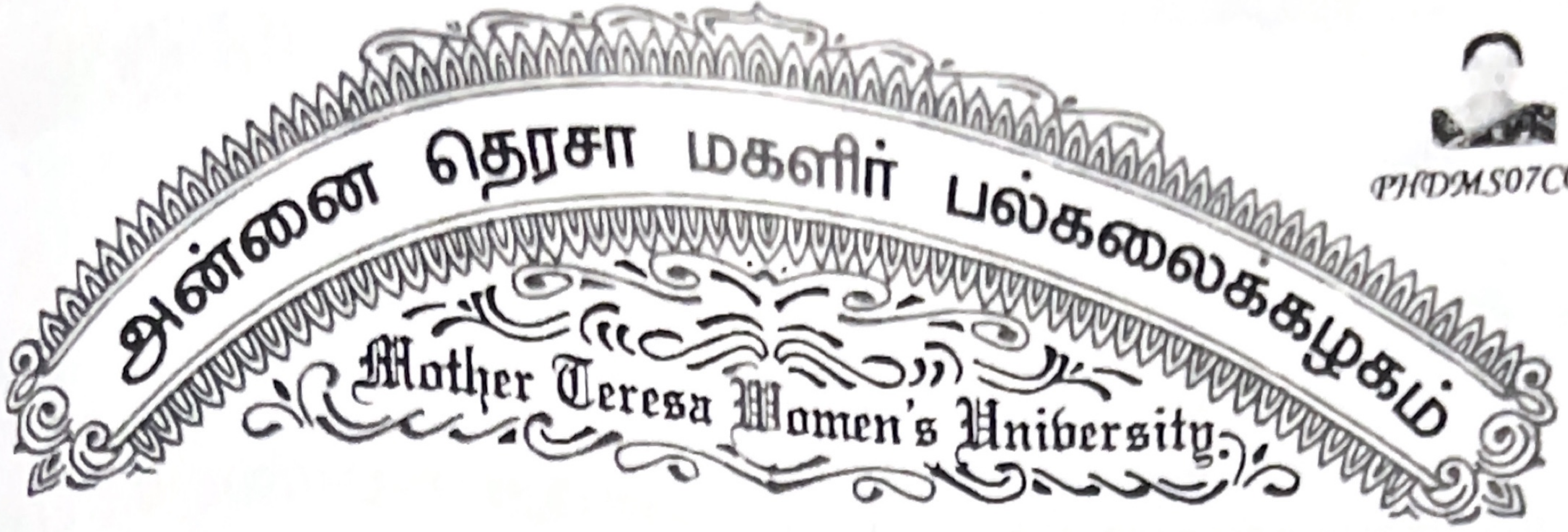



- The recognized research supervisor shall be permitted to guide only in the discipline approved. In case of interdisciplinary research, it will be considered based on the merits of research expertise.
- If, for any reason, the research supervisor takes voluntary retirement from service or leaves the service or moves away from the jurisdiction of the University, the guideship shall stand cancelled. However, such research supervisor shall be permitted to complete their commitments to the students already registered.
- As per the existing regulations, an **Assistant Professor** can accommodate upto a maximum of **one (1) M.Phil** and **four (4) Ph.D.**, scholars at any given point of time.
- This recognition of guideship shall be governed by the Ph.D. Regulations of the Madurai Kamaraj University in force and shall also be subject to amendments, if any, from time to time.
- The research supervisors in the approved research centres are informed to enroll their details on the Research portal of the University website through the Head of the Departments concerned.
- The research supervisors in the non-research departments are informed to enroll their details through the separate link provided in the Research webpage of the Madurai Kamaraj University website.
