#### Abstract

The Khadi and Village Industries Commission is a statutory body formed on April 1957 by the Government of India under the act of parliament "Khadi and village industries commission act of 1956". It plays a vital role in the economy as it is one of the major generating industry in the Indian economy. Khadi implements the programmes of KVIC in India through over 2737 institutions and over 4.97 lakhs of people are involved to handle this activity. The main trust of KVI activities is to provide a large share of employment to the schedules caste, tribes and women. The need for the present article is to analyze the financial performance of Khadi and village Industries commission in terms of production and sales. For the purpose of studying the financial performance of Khadi and Village Industries commission, the data has been collected from secondary sources such as journals, MSME site and other website. The collected data has been presented in the tables with the help of statistical tools.

### Introduction

The Khadi and village Industries Commission is playing a predominant role in Indian economy making a part of rural industrial sector. The concept of Khadi emerged after Indian independence when Khadi and village industries production was spoken as a piece of cloth but was identified as the greatest symbol of nationalism, a symbol of freedom of self-reliance. The KVIC is a statutory body formed in April 1957 by the government of India, under the act of parliament," Khadi and village Industries commission Act of 1956. It is an apex organization under the Ministry of Micro, Small and Medium Enterprises, Government of India. They are a major contributor of sustainable development by providing employment mostly to the weaker section of the society in which the women play the substantial part of the work force. Khadi implements the programmes of KVIC in India through over 2737 institutions and over 4.97 lakhs of people are involved to handle this activity and the important part is that the women artisans contribute over 80%. The Khadi institutions are provided assistance through modified market development (MMDA) and employment opportunities are provided by interest subsidy eligibility certificate (ISEC) schemes. There are six different sectors in village industries which are as follows

- Agro bases and food processing industries (ABFPI)
- Mineral bases industry (MBI)
- Wellness and cosmetic industries (WCI)
- Handmade paper, leather, plastic industry (HMPLPI)
- Rural engineering and new technology industries (RENT)
- Service industry

Hence village industries are providing non-farm employment opportunity to good extent in rural areas with a very low capital investment.

#### **Review of Literature**

Peter, Pesala. (2014) in their study "A Case Study of Khadi Institutions in India" identified 200 Khadi institutions in India and concluded that the Khadi industry has high potential for future growth and most of the institutions are suffering from shortage of working capital for the implementation of latest technology. Effective Management Information System should be executed for effective networking overall India.

Harikumar (2021) in their study "Performance of Khadi and Village Industries in India" analyzed that KVI sector has maintained sustainable development in terms of production and sales. Village Industrial sector is performing well than Khadi sector in case of employment. The Government has implemented various polices towards KVI sector to provide rural employment and to improve rural economy.

Bhaskaran (2009) in their study" The performance of Khadi and Village Industries" studied the physical and financial performance of KVI based on three important variables like Employment, Production and sales. The study concluded the high degree of relationship between production and sales of KVI. As far as employment generation is concerned, KVI should make use of infrastructure support, direct catalytic subsidy support, technical and marketing support.

Anandi Sarkar (2017) in their study "An exploratory study on Khadi Industry in India" recommended to follow integrated credit system to meet the long term and short term credit requirements of the MSME's. The government can adopt technological transformation of rural enterprise, cluster approach for generating marketing opportunities.

## **Statement of the Problem**

The aims of KVIC is to provide employment in rural areas, producing saleable articles, and creating self-reliance amongst people and building up a strong rural community spirit. Khadi and Village Industries are providing the key source of livelihood for the rural and urban people living across the country who largely include Spinners, Weavers and other Artisans. The Ministry of Micro, Small and Medium Enterprise (MSME) provides funds to KVIC for undertaking various activities. In spite of the potential support provided by the central government as well as KVIC, the Khadi and Village Industrial sector has been performing significantly in production and sales. The purpose of the study is to identify the recent financial performance of Khadi and Village Industrial Sector in terms of production and sales.










